MINUTES OF THE MEETING OF THE BILTON IN AINSTY WITH BICKERTON PARISH COUNCIL HELD IN TOCKWITH SPORTS HALL ON MONDAY 19 FEBRUARY 2024

Prior to the meeting commencing under standing orders, the Chairman thanked the Bickerton Grange Farm Manager for attending the meeting to discuss issues in Bickerton.

The two commemorative bench seats outside Stud Farm in Main Street Bickerton, have now been repaired and reinstalled/secured in their previous locations. The Chairman asked if the Farm Employee who lives in Stud Farm could be asked to assist by using his CCTV to monitor any activities near the replaced bench seats when it is dark. The Farm Manager agreed to ask the Stud Farm occupant if he could help.

The Farm Manager also sought the Parish Council's assistance to address the regular flooding problems on the B1224. This has recently caused repeated accidents when unsuspecting vehicle drivers have aquaplaned through field hedges in the dark, due to standing water on the highway. The Chairman confirmed that the Clerk had knowledge of the previous work undertaken, when he liaised with Area 6 to solve this problem some years ago. The Farm Manager agreed to write to the Parish Council formally seeking its support in asking Area 6 to address this problem with some urgency.

The Chairman thanked the Farm Manager for attending the evening meeting.
