3.	<u>Minutes of the Meeting held on 17 June 2024</u> The minutes of the meeting held on 17 June 2024 were approved as a true record by all Cllrs present without abstention.	
4.	<u>Highway Matters</u>	
4.1	On Line Meeting With Area 6 -10 July 2024 The Clerk represented the PC at the 'on line' teams meeting and criticised Area 6 for issuing a letter regarding hedge cutting with a time scale in June when legislation restricts the work during the bird nesting season. The indiscriminate circulation of the letter /directive to residents with garden walls and no hedges had caused anger and frustration with the Parish Council being accused of being the instigator of the offending letter. The Area 6 communications Officer apologised for the errors that had occurred.	
4.2	Following the serious traffic accident between a tractor and speeding HGV on the B124 at Bickerton, PC Olesquie from NY Police advised that no action could be taken as there was no evidence of the speed of traffic on this section of highway. The Clerk recommended that NY Council Officers should be asked to carry out a survey to determine traffic speed. All Clls present with no abstention agreed that a speed survey be requested via County Cllr A Paraskos.
